

HEALTH SAFETY ACKNOWLEDGEMENT, LIABILITY WAIVER AND RELEASE OF CLAIMS

Upon attending any in person National Customs Brokers and Forwarders Association of America's ("NCBFAA") meetings and events:

I acknowledge and agree that NCBFAA and Hotel have put in place preventative measures designed to reduce and prevent the spread of transmissible diseases, including COVID ("Protocols") during the Meeting and I: (i) understand that my travel to and from, and my attendance at, the Meeting may expose me to an increased risk of contracting transmissible diseases, (ii) understand that NCBFAA cannot guarantee that I will not become infected with a transmissible disease, or a variant thereof, (iii) acknowledge that I will attend the Meeting at my own free will and risk, and (iv) acknowledge that: (a) I have had unrestricted access to review and understand the Protocols, (b) the Protocols are reasonable and acceptable, and (c) I have been advised to contact NCBFAA and/or Hotel if I have any questions about the Protocols and/or my safety.

I hereby acknowledge the contagious nature of all transmissible diseases and voluntarily assume the risk that I may be exposed to, or infected by, a transmissible disease by traveling to and from and/or by attending the Meeting, and that such exposure or infection may result in illness, permanent disability, or death. I understand that such injury may result from the actions, inactions, omissions or negligence of myself and others, including, but not limited to NCBFAA employees, Meeting attendees, Hotel and its employees, exhibitors, or other groups or persons present in Hotel unrelated to the Meeting.

I hereby release, covenant not to sue, discharge and hold harmless NCBFAA and its employees, members, agents, and representatives of and from all liabilities, claims, actions, damages, costs and expenses of any kind arising out of or relating to my voluntary attendance at the Meeting. I understand and agree that this release includes any claims based on the actions, inactions, omissions, or negligence of NCBFAA, its employees, agents, and representatives, whether a transmissible disease infection occurs before, during or after the Meeting.

I agree to comply with all transmissible disease-related procedures that may be implemented by NCBFAA and Hotel, including, but not limited to, the Protocols and mask wearing and social distancing requirements and restrictions on certain activities that carry a higher transmissible disease-related risk, in order to protect the health and safety of all Meeting attendees. Additionally, I agree to self-monitor for signs and symptoms of transmissible diseases, and if I experience any transmissible disease-related symptoms during the Meeting I will immediately: (i) notify an NCBFAA staff member, and (ii) discontinue my participation and take all appropriate action to limit my exposure to others.

I agree that I: (i) may only attend the Meeting if I agree to the terms set forth in this Liability Waiver and Release of Claims and (ii) will abide by federal, state, and local health and safety guidelines prior to the Meeting.
